Dear Mr. Wheatley:

On January 29, 2021, Albireo Energy, LLC (Albireo) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on February 11, 2021, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Albireo's registration renewal application be approved for a two-year term, beginning on May 1, 2021.

The Commission has approved Staff's recommendation. Accordingly, Albireo's application for registration renewal is approved, effective as of May 1, 2021. The renewed registration is for a term of two years and expires at the close of business on May 1, 2023. Pursuant to Puc 3003.06(a), Albireo must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before March 2, 2023.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
