Dear Ms. Cucio:

On May 3, 2021, Satori Enterprises, LLC (Satori) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Commission Staff filed a memorandum on May 13, 2021, summarizing its review of the application and recommending that a waiver be granted of the renewal application filing deadline under N.H. Admin. R., Puc 2003.06(a) and that Satori's registration renewal be approved for a two-year term, beginning on May 2, 2021, pursuant to Puc 2003.06(e)(1).

The Commission has granted the recommended rule waiver, having found that it would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, under Puc 201.05. Accordingly, Satori's application for registration renewal is approved, effective as of May 2, 2021, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on May 2, 2023. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before March 3, 2023.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.
