Granting Extension of June 1, 2021 Deadline

To the Parties:

In Order No. 26,475 (April 30, 2021), the Commission directed Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities – Keene Division (Liberty Keene or the Company) to work with Commission Staff (Staff) and the Office of the Consumer Advocate (OCA) to resolve Staff concerns about non-rate contract terms on an expedited basis. The Commission also directed Liberty Keene to file a fully executed amended compressed natural gas supply contract on or before June 1, 2021, to take effect July 1, 2021.

On June 1, 2021, Liberty Keene filed a request to extend the Company's filing deadline to June 8. Liberty Keene reported that it was requesting an extension of the deadline because the other party to the contract, "XNG" (Xpress Natural Gas LLC), had not yet indicated whether it would accept the proposed revisions.

The Commission has reviewed Liberty Keene's request, and it has determined that the standards for an extension of time contained in New Hampshire Code of Administrative Rules, Puc 202.04 have been satisfied. Accordingly, the deadline identified in Order No. 26,475 at 11 is extended from June 1, 2021 to Tuesday, June 8, 2021.
