To the Parties and Stakeholders:

At the request of the New Hampshire Department of Energy (Energy), the Commission cancelled the July 15, 2021 stakeholder technical session with consultant Dunskey Energy Consulting/Power Advisory LLC regarding the Value of Distributed Energy Resources (VDER) Study by letter dated July 15, 2021. Although the Commission required Energy to notify it by July 29, 2021 of the date on which the parties agreed to reschedule the technical session regarding the VDER study, as of today's date, Energy has not notified the Commission of the new date.

Therefore, unless Energy has notified the Commission by September 9, 2021 of a date on which the participants in this matter have agreed to reschedule the technical session or has advised the Commission that the technical session is no longer necessary, the Commission will reschedule the technical session for a date thereafter.
