**Procedural Order Re: Rescheduled Hearing**

By procedural order dated November 2, 2021, as a result of an emergency, the Commission postponed the November 2, 2021 hearing in the above-captioned matter for the Commission to consider evidence related to Abenaki Water Company, Inc.'s rate base. The Commission acknowledges the letter filed by the Office of the Consumer Advocate on November 2, 2021 requesting that this hearing not be rescheduled, which the Commission has reviewed and considered.

The Commission has rescheduled the hearing to Monday, November 8, 2021, from 1:00 p.m. to 4:30 p.m. A hybrid hearing format will be used for the November 8 hearing, in accordance with the procedural order dated October 22, 2021 and the evidentiary hearing guidelines issued on October 13, 2021. 
