Request for Change in Rates

Procedural Order Re: Request for Remote Participation

On November 30, 2021, Pennichuck East Utility, Inc. (PEU or the Company), on behalf of itself, Richard Husband, the Office of the Consumer Advocate, and the Towns of Litchfield and Londonderry, filed a request to appear remotely at the December 15, 2021 hearing in the above-captioned matter. PEU stated that the reasons for its request were health concerns associated with contracting COVID-19, given the increase in COVID-19 infections, and Company COVID-19 guidelines discouraging large, face-to-face, group meetings. According to PEU, the New Hampshire Department of Energy assents to its request.

No objections to these requests were filed, and sufficient reason for a hybrid hearing format has been provided. To the extent that New Hampshire Code of Administrative Rules Puc 203.07(e) provides 10 days for objections, it is hereby waived. Therefore, a hybrid hearing format will be used for the December 15, 2021 hearing. Those who wish to participate in or observe the hearing remotely via the web may do so [by clicking here](#).
