To the Parties:

By Secretarial Letter dated March 16, 2006, the Commission notified the parties to this docket that the Model Rules of Practice and Procedure developed by the New Hampshire Department of Justice found at Jus 800 would apply to this proceeding pending readoption of the Commission's procedural rules, N.H. Code Admin. Rules Puc 200.

On March 22, 2006, Pennichuck Water Works, Inc. (PWW) filed a Motion to Waive Application of Jus 800 Rules and Instead to Apply Puc 200 Rules arguing that such relief is justified under the waiver standard set forth in Jus 803.03 because it "would be more likely to promote the fair, accurate and efficient resolution of issues pending before the [Commission]".

Inasmuch as the Commission voted to adopt Puc 200 at its June 8, 2006 public meeting, PWW's Motion to Waive Application of Jus 800 Rules is moot.
