

**SPRINT COMMUNICATIONS COMPANY, L.P. AND
SPRINT SPECTRUM L.P.'S ESTIMATE OF IMPROPERLY BILLED VERIZON NEW
HAMPSHIRE ACCESS CHARGES**

Sprint Communications Company, L.P. and Sprint Spectrum L.P. (collectively, "Sprint Nextel") hereby submits the following estimate of the general order of magnitude of the disputed charges billed by Verizon New Hampshire ("Verizon"), in accordance with Order No. 24,705 dated November 29, 2006. Sprint Nextel's estimate amount of improper access is based upon bills submitted to it by Verizon.¹

To calculate this amount, Sprint Nextel compiled all the New Hampshire Intrastate Carrier Common Line ("CCL") charges invoiced to them by Verizon for the bill dates beginning with February 13, 2006. Sprint Nextel then excluded all end office locations identified by the Local Exchange Routing Guide ("LERG") to be owned by Verizon OCN 9102 and 5113 from the data. The remaining amount was determined to be transiting minutes of use and therefore, Sprint Nextel concluded that those CCL charges were improperly invoiced to Sprint Nextel.

¹ Sprint Nextel expressly reserves the right to refine this estimate and to supplement the estimate as well as supporting information if necessary.

The initial backclaim dispute of twenty four months consisted of eleven months of actual invoiced CCL charges as well as thirteen months of estimated CCL charges based upon an average amount from the invoiced data. This estimate was necessary due to a billing conversion that occurred and the time and expense to extract data from the older files. The claims going forward for subsequent CCL charges which continues to be invoiced to Sprint Nextel follows the same methodology to calculate the dispute as described above.

The attached work papers are submitted in support of Sprint Nextel's calculations. Sprint Nextel considers the information contained therein to be confidential, proprietary and competitively sensitive financial information and therefore is being submitted to the Commission only, pursuant to RSA 378:43.²
