The North Hampton Water Commission requests the following, related to our oversight of Aquarion per the authority granted by Town Meeting in 1957. We petition intervener status in behalf of North Hampton residents regarding matters concerning the water company servicing North Hampton. In addition to the interests of its residential and commercial residents in this service area, the North Hampton Water Commission is also concerned with the Aquarion commercial production pumping wells which have been constructed in North Hampton to draw water from the aquifers within the Town borders to supply North Hampton, Hampton and Rye.

The above referenced issue has arisen so quickly that the Town of North Hampton hasn't had an opportunity for the Board of Selectmen to notice a Selectmen's meeting to discuss with the North Hampton Water Commission all of our "rights, duties and privileges" as mentioned in Aquarion's petition as required documentation for North Hampton to petition for Intervener status in this issue. Please be advised, that the North Hampton Water Commission may be amending this Petition to Intervene, if necessary, with

additional "rights, duties and privileges" to intervene after a meeting with the Board of Selectmen.

Therefore,

1) The North Hampton Water Commission petitions intervener status regarding the above mentioned petition by Aquarion for the PUC's approval that Aquarion be acquired by Macquarie.


