To the Parties:

On May 7, 2007, the Commission issued in the above captioned proceeding a secretarial letter that, among other things, set July 31, 2007, as the date for a hearing on the merits. On June 14, 2007, Staff requested a suspension of the procedural schedule to accommodate discovery on a filing made by Northern Utilities, Inc. on June 5th that revised and supplemented its 2006 Integrated Resource Plan and certain discovery responses regarding Northern's design planning standard. Staff reports in its request that the other parties do not object to suspending the proceeding.

Based on the foregoing, the Commission has suspended the procedural schedule until further notice. The parties are directed to advise the Commission of a revised procedural schedule including a date for the hearing on the merits as soon as possible.
