On August 29, 2011, you filed on behalf of EnergyNorth Natural Gas, Inc. d/b/a National Grid NH and Granite State Electric Company d/b/a National Grid (collectively, "the Companies") a request to extend the time to September 7, 2011 to file reports and other filings in a number of matters in which a deadline applicable to the Companies to make such filings occurs during the week of August 29, 2011. In your request, you note that storm conditions related to Hurricane Irene have required the Companies to focus their efforts on restoration activities and those persons responsible for preparing filings have been reassigned to assist in those efforts.
