

PETITION FOR INTERVENTION

NOW COMES Freedom Partners, LLC d/b/a Freedom Energy and hereby petitions the New Hampshire Public Utilities Commission for full party status in the above-captioned proceeding pursuant to RSA 541-A:32, I(b) and NH Code Admin.Rule Puc 203.17. In support of its Petition for Intervention, Petitioner says the following:

- 1. On September 8, 2006, Public Service Company of New Hampshire (PSNH) filed with the New Hampshire Public Utilities Commission (Commission) a petition to establish the company's Default Energy Service Rate (Energy Service Rate) for bills rendered on or after January, 2007.
- 2. Freedom Partners, LLC, is a non-traditional retail energy marketing company serving the New England states. Freedom supplies both electricity and natural gas commodities to the commercial, industrial, institutional and government sectors. Freedom's unique approach to serving this sophisticated market segment is based upon its ability to structure creative, multifaceted cost saving supply arrangements that capitalize on the full benefits of wholesale markets
- 3. Freedom Energy is a licensed competitive retail provider license in Maine, and expects to receive a license in New Hampshire upon successful completion of EDI testing which is presently underway. Freedom Energy also has filed applications for a competitive retail provider license in Massachusetts, Rhode Island, and Connecticut. Freedom Energy also possesses a federal power marketers license and is a member of NEPOOL/ISO-NE.
- 4. Freedom Energy has entered into an agreement with Coral Energy Holdings, L.P. whereby Coral will provide various supply and related management functions to Freedom and will satisfy the credit assurance requirements that may be imposed on Freedom. Coral Energy, an affiliate of Shell (www.shell.com), operates as part of the global Shell Trading network in North America and provides a comprehensive portfolio of energy-related products and services associated with wholesale natural gas and power marketing and trading.

5. Stephen J. Fabiani is the President of Freedom Energy. Mr. Fabiani was formerly vice president of retail sales and marketing for Select Energy, a Northeast Utilities' competitive subsidiary.

6. As an energy marketer providing an alternative to PSNH's Default Rate, Petitioner has a strong interest in the outcome of this proceeding that could substantially affect its rights, duties, privileges and other substantial interests such as its opportunity to advise and sell to PSNH's customers.
