Dear Ms. Howland:

On September 7, 2007, Public Service Company of New Hampshire (PSNH) filed with the Commission a Petition for Proposed Default Energy Rate for 2008 (Docket No. DE 07-096). On September 25, 2007, the Commission issued an Order of Notice setting a prehearing conference for October 9, 2007 at 11:00 a.m. The prehearing conference was held, at which time the Commission granted a Petition for Intervention filed jointly by the Constellation NewEnergy, Inc. and Constellation Energy Commodity Group, Inc. (collectively "Constellation") and took initial positions of the parties. Following the prehearing conference, Staff, PSNH, Constellation and the Office of Consumer Advocate held a technical session to establish a procedural schedule. The following represents the procedural scheduled agreed to at the technical session:
