On September 16, 2008, Staff filed a report following the September 12, 2008 technical session in the above referenced proceeding. Staff represents in its report that there is agreement among the parties on the disposition of this case, noting that the Office of the Consumer Advocate takes no position. With the acceptance of pre-filed testimony on behalf of Comcast and the New Hampshire Telephone Association (NHTA) into the record, the parties have agreed to cancel the September 22nd hearing and proceed with briefing on an expedited schedule.
