**Rate Recoupment Period Options** 


Dear Ms. Howland:

Please find time period options for the proposed recoupment for the difference between temporary rates and permanent rates reconciled back to June 6, 2008 for the customers in the Town of Pittsfield. This submission is made in accordance with Order 25,051 issued on December 11, 2009 that directed the Company to submit options for the time frame for the credit to fire protection customers.

The surcharge is calculated based on the actual usage, customer and fire protection charges for each General Metered and fire protection customer and implemented in a manner that is consistent with the September 2009 updated cost of service study.

The attached schedule reflects the average monthly surcharge/credit recoupment options for the periods from 12 to 18 months for each customer class. The Company is recommending that the surcharge/credit recoupment occurs over 18 months. The Company is also recommending that the recoupment time period be the same for each customer class to provide a balanced flow of surcharge/credits to the customers and a balanced flow of revenue/cash flow to the Company. Specifically, the Company is recommending the following:
