Staff and the parties met in a conference today and agreed that we wish to proceed by way of Track One rather than Track Two for the remainder of the procedural schedule. When Staff and the parties first requested the Commission's approval of a procedural schedule, Staff and the parties identified two tracks, one for settlement and the other allowing for litigation of the issues. It has become evident to Staff and the parties that Track Two can be eliminated.

Secondly, Staff requests the date for filing a settlement agreement in this docket be moved from the present 9/12/08 to 9/24/08.
