

Renewal Registration as a Competitive Natural Gas Supplier

Dear Ms. Hankins:

On January 6, 2009, Global Montello Group Corp. filed with the New Hampshire Public Utilities Commission (Commission) a renewal application for registration as a competitive natural gas supplier (CNGS), together with a check in the amount of \$250.00. As part of its renewal application for registration, Global filed a \$100,000 executed parent guaranty with a term which shall continue in full force and effect until the Guarantor seeks termination and upon giving sixty (60) days written notice to the Commission.

The Commission has reviewed both the Global Montello Group Corp. renewal application for registration as a CNGS and the executed parent guaranty submitted with the application. Its application, with the executed guaranty, meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.01. Therefore, the Commission will approve the renewal application for Global Montello Group Corp. as a CNGS in the State of New Hampshire, with the registration to be effective March 16, 2009. This registration will expire at the end of business on March 15, 2011 or on the earlier termination or expiration of the executed parent guaranty.

Additionally, please bear in mind the following provisions of Puc 3003.01:

Pursuant to Puc 3003.01 (d), each CNGS applicant shall re-register with the Commission every 2 years by filing an application for renewal. Each CNGS applicant shall file an application for renewal at least 60 days prior to the expiration of its registration.


Pursuant to Puc 3003.01 (e), each CNGS shall include on each renewal application an update, including any changes, to all information contained in the previous application. If a CNGS fails to meet its re-filing obligation, the original registration shall expire.

Pursuant to Puc 3003.01 (i), a CNGS shall notify any LDC in whose service territory it intends to do business of the filing of its registration or renewal application at the time its files such application with the Commission.

Accordingly, Global Montello Group Corp. application for renewal would be due January 14, 2011.
