## **BASIC LOCAL EXCHANGE SERVICE** DIRECT INWARD DIALING (DID) TRUNK SERVICE

### Description

- A. DID service permits calls incoming to a PBX or other customer premises equipment from the network to reach a specific station line number without the assistance of an attendant.
- B. DID service is furnished for use with compatible customer premise equipment subject to the regulations specified in Part 3.
- C. DID is designed for voice communications, not for the transmission of data. Data transmission is not guaranteed over facilities equipped with DID.
- D. All DID calls must be routed over the same PBX trunk group. Trunk lines arranged for DID may not be mixed in a trunk group with trunk lines not arranged for DID.

#### II. Responsibility of the Telephone Company

- A. The Telephone Company accepts no responsibility for reserving telephone numbers to be used at a future time. If the provision of additional service necessitates telephone number change, service and equipment charges will apply.
- B. DID numbers are provided in groups of 20 number blocks which may be assigned to Customer station lines. The Customer has no property right to the telephone number assigned in the DID block.

#### III. Responsibility of the Customer

- A. DID is furnished upon the condition that the customer must subscribe to adequate facilities (e.g. trunks, circuit packs, etc.) to permit the use of the service without injurious effect on general telephone service.
- B. The customer is responsible for providing interception of calls to vacant or nonworking assigned station lines or telephone numbers by means of attendant intercept or a recorded announcement.
- C. Requests for number blocks will be submitted by Customer writing prior to activation.
- D. Customer minimum commitment period for the service is two (2) years. In case of discontinuance or reduction of service within the minimum commitment period, a basic termination charge equal to 24 months of the rates for service terminated reduced by 1/24<sup>th</sup> for each full month of service provided shall apply. Customer must select a minimum of 8 trunks; a combination of DID trunks and PBX trunks may be ordered to meet the minimum requirement.
