Comcast Petition for Waiver of Certain CLEC Rules

Dear Ms. Geiger:

On November 10, 2011, the Commission issued Order No. 25,288 which, in part, granted a 60-day waiver of portions of Commission rules Puc 430 and Puc 450. The Order also directed Comcast to review the rules and determine whether there are portions of the rules with which it could not comply, and to report to Commission within 45 days. On December 21, 2011, Comcast filed a petition for a permanent waiver of 12 specific rules and on January 3, 2012, various incumbent carriers objected to the petition.

The Commission has determined that it is in the public interest to extend the previous temporary waiver, as defined in Order No. 25,288, pending a ruling on the petition. The Commission reasserts its determination that Comcast shall continue to comply with those rules with which it complies at present, *New Hampshire Telephone Association*, Order No. 25,288 (Nov. 10, 2011) at 9, pending a decision on its request for a permanent waiver.
