The proposed COG rate is .0701 per therm, a 1847 per lherm decrease m the weighted residential DG rate of \$2.2548 per erm for last summer. The timated impact of the proised COG rate and elimiation of the deferred reviue surcharge on a typical sidential heating cusmer's summer gas costs II be a decrease of \$208, 36% compared to last

The filing raises, inter alia, sues related to: RSA 378 hd the justness and reaonableness of rates, fares, nd charges; the reasonpleness of sales forecasts, applier prices, and transprtation prices; reconciliaon of prior period costs and evenues; the causes and 'Autu eatment of a prior period ver recovery; and rate npacts resulting from the

oposed rate changes. An additional issue in this ocket held over from a prior ocket (DG 08-117, NHGC's 1008/2009 Winter COG) Jets cludes the question of hether the mechanism that llows monthly changes in

the COG rate without further Commission action should be modified to allow greater flexibility. Each party has the right to have an attorney represent them at their own expense.

FURTHER ORDERED, that pursuant to N.H. Admin. Rules Puc 203.12, NHGC shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than March 30, 2009, in a newspaper with general circulation in those portions of the state in which operations are conducted, publication to be documented by affidavit filed with the Commission on or before April 21, 2009; and

FURTHER ORDERED, that pursuant to N.H. Admin. Rules Puc 203.17, any party seeking to intervene in the proceeding shall submit to the Commission seven copies of a Petition to Intervene with copies sent to NHGC and the Office of the Consumer Advocate on or before April 16, 2009, such Petition stating the facts demonstrating how its rights, duties, privileges, immunities or other substantial interest may be affected by the proceeding, as required by N.H. Admin. Rule Puc 203.17 and RSA 541-A:32,I(b); and it is

FURTHER ORDERED, that any party objecting to a Petition to Intervene make said Objection on or before April 21, 2009.
