Request for Additional Time to File Legal Memoranda

To the Parties:

On March 10, 2010, Public Service Company of New Hampshire (PSNH) filed a letter requesting that the Commission reconsider the date by which it requires the filing of legal memoranda in the above referenced matter. In support of its request, PSNH states that, on January 7, 2010, it filed an application with the Federal Energy Regulatory Commission (FERC) to terminate PSNH's mandatory obligation to purchase power from qualified facilities with net generating capacity of 5 megawatts or greater. FERC Docket No. QM10-4-000. PSNH specifically requests that the Commission delay the filing date until one month after FERC issues a final, unappealable order regarding its application. On March 12, 2010, Clean Power Development LLC filed an objection to PSNH's request for an extension.

Please be advised that the Commission has denied PSNH's request. Because the original deadline for briefs is a matter of days, the Commission has extended the deadline for submissions from March 26, 2010 to April 2, 2010.
