Petition for Authority to Issue Long Term Debt Pennichuck East Utility Effective November 9, 2009

On July 28, 2009, Pennichuck East Utility, Inc. (PEU) filed a petition for authority to issue long term debt. PEU seeks to borrow \$6 million with a 20-year term at an interest rate in the range of 6 to 6.5%.

The purpose of the financing is 1) to refinance a \$4.5 million floatingrate secured note that matures on December 31, 2009; 2) to provide \$1.5 million for PEU's on-going capital improvement program; and 3) to repay short term borrowings by PEU from its parent.

The Commission issued an Order Nisi on November 9, 2009 approving the financing. An Order Nisi provides customers or other interested parties with the opportunity to submit comments or request a hearing on the proposed financing. The request for hearing should state the reason and basis for the request and be submitted to the Commission no later than November 25, 2009. In addition, any customer or other interested party may respond to any request for hearing, submitting their comments on the request no alter than December 1, 2009. Absent any request for, and granting of a request for, a hearing or further action by the Commission, approval of the proposed financing will become effective as of December 8, 2009.
