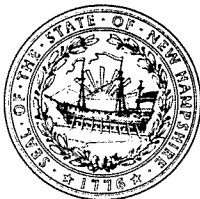

Certification Applications for Class II Eligibility Pursuant to RSA 362-F

Dear Mr. Unger:

On November 17, 2009, you submitted applications on behalf of Boston Community Capital Solar Energy Advantage, Inc. (BCC) requesting certification of three customer-sited rooftop photovoltaic facilities (BCC facilities) as eligible to produce Class II Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed your applications and recommended approval noting that the applications were complete on November 17, 2009.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the facilities are customer-sited photovoltaic rooftop arrays located in Hopkinton, Massachusetts and the facilities began operation in 2009. The details for each facility are listed in the following table:



The NEPOOL GIS facility codes have not yet been obtained. You are required to provide the facility codes to the Commission as soon as they are obtained from the GIS administrator. The ISO-NE asset identification number is not applicable as the BCC facilities are behind-the-meter sources. Your applications indicate that since the BCC facilities are behind-the-meter sources, PowerDash LLC, as the facilities' independent monitor, will verify and report the facilities' output to the NEPOOL Generation Information System (GIS) pursuant to the GIS Operating Rules.

Based on Staff's recommendation, the Commission has determined that BCC has provided all the necessary information to demonstrate that its facilities are eligible for certification as Class II facilities. Therefore, the Commission hereby certifies the BCC facilities are Class II renewable energy sources effective November 17, 2009 and are eligible to be issued New Hampshire Class II RECs.

Attached please find a copy of the notice of these certifications provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification codes for the BCC photovoltaic facilities are listed in the table on the previous page.

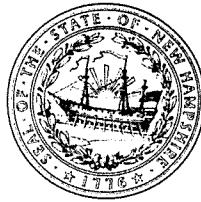

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified three customer-sited rooftop photovoltaic facilities owned by Boston Community Capital Solar Energy Advantage, Inc.'s (BCC) as Class II renewable energy sources effective November 17, 2009. Accordingly, the BCC facilities are eligible to be issued New Hampshire Class II Renewable Energy Certificates.
