Re: DE 09-106, DE 09-107, DE 09-108, DE 09-109, DE 09-110, DE 09-207, DE 09-208, DE 09-228, DE 09-229 and DE 09-230, Boston Community Capital Solar Energy Advantage, Inc.'s Request for Class II Eligibility of its Aggregated Customer-Sited Sources

Dear Mr. Unger:

On December 10, 2009, you submitted a letter on behalf of Boston Community Capital Solar Energy Advantage, Inc. (BCC) to the Commission requesting certification of the Boston Community Capital Solar Energy Advantage, Inc. Aggregation 1 (BCC Aggregation) as eligible to produce Class II Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. According to your request, the BCC Aggregation represents all of BCC's customer-sited photovoltaic facilities that have received New Hampshire Class II REC eligibility. In lieu of using the certification codes previously issued by the Commission, BCC would have a single certification code. A single certification code from the Commission would permit the NEPOOL generation information system (NEPOOL GIS) to recognize all of the eligible BCC facilities as a single generator, and it would then issue RECs for BCC Aggregation's total monthly output. Staff has reviewed your request and recommended the Commission approve your request before January 10, 2010, the NEPOOL GIS deadline for reporting third quarter 2009 electricity production from customer-sited and behind-the-meter sources.

According to your letter, BCC has already applied for and received a GIS facility code for the BCC Aggregation. The GIS facility code, NON 32833, will allow BCC's independent monitor, PowerDash LLC to report the total monthly output of the facilities in lieu of reporting output for each facility. BCC needs a single certification code for all of its Class II REC eligible facilities by January 10, 2010 to allow the NEPOOL GIS to issue Class II RECs for the electricity produced during the third quarter of 2009.

The Commission recently approved all of your customer-sited photovoltaic sources as Class II REC eligible facilities. Each facility's New Hampshire certification code and effective date to receive Class II RECs are listed in the following table.

Based on Staff's recommendation, the Commission hereby certifies the BCC Aggregation to receive New Hampshire Class II RECs. To ensure that BCC does not receive Class II RECs for output from facilities not approved for Class II eligibility during the third quarter 2009, BCC must report to the Commission the total output associated with the facilities after the original Commission issued effective dates. Specifically, BCC must provide each facility's kilowatt-hours (kWh) produced during the relevant quarter, total kWh produced prior to the Commission approval date to produce Class II RECs, and total kWh produced after the Commission approval for Class II RECs. BCC must submit this quarterly data to the Commission before the NEPOOL GIS

deadline for reporting customer-sited facility output. For example, for third and fourth quarter of 2009 data, BCC must submit this data prior to January 10, 2010 and April 10, 2010, respectively.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for the BCC Aggregation is NH-II-10-001.


Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Boston Community Capital Solar Energy Advantage, Inc. – Aggregation 1 (BCC Aggregation) as eligible for Class II Renewable Energy Certificates (RECs). Accordingly, the BCC aggregation is eligible to be issued New Hampshire Class II Renewable Energy Certificates (RECs), effective August 3, 2009, the date on which the Commission awarded New Hampshire Class II REC eligibility for the first five facilities listed in the table on the following page.

For the electricity produced during the third and fourth quarters of 2009, BCC can only receive New Hampshire Class II RECs for the output from Class II REC eligible facilities beginning the original effective date of each source. To ensure that BCC does not receive Class II RECs for output from facilities not approved for Class II eligibility during the third quarter 2009, PowerDash LLC must report to the NEPOOL GIS the total output associated with the facilities after the original Commission issued effective dates listed. BCC can then receive Class II RECs for the total aggregation for output produced during the first quarter 2010 and thereafter.
