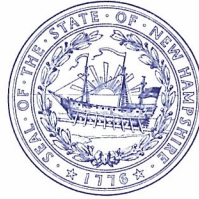

On April 8, 2010, following the pre-hearing conference representatives of EnergyNorth Natural Gas, Inc. d/b/a National Grid NH, the Office of Consumer Advocate, Commission Staff and interested intervenors met in a technical session. As a result of that technical session the parties and Staff developed the following proposed procedural schedule for the Commission's consideration:
