Residential Solar Rebate Program Status

To Interested Persons:

As previously announced, the Sustainable Energy Division's rebate and grant programs are experiencing record demand and the program budget allocations for fiscal year 2017 are fully subscribed. Today, Staff informed the Commission that the waitlist for the Residential Solar Rebate program exceeds \$500,000. Therefore, starting July 1, 2017, any Step 1 application for the Residential Solar Rebate program will not be processed or placed on a waitlist. No further action will be taken on these applications until the alternative compliance payment revenue is fully reconciled and the fiscal year 2017 program requirements and allocations are determined. Program budget allocations along with any necessary program modifications will be forthcoming.
