






Request for Acceptance of Delayed Filing (PUC 201.05)

Dear Ms. Howland:

Metromedia Energy's gas supplier re-registration application is being filed separately and simultaneously today with this letter. It does not meet the Section 3003.01 (d) requirement that a supplier's registration renewal application be filed at least 60 days prior to the expiration of their registration. Consequently, we are requesting that the Commission allow this delayed filing pursuant to the Section 201.05 Waiver rule for the reasons provided below.

It is essential to the re-registration process that new and updated information is provided to the Commission on a timely basis. There have been significant changes in the Company's capacity, delivery and storage arrangements since the last registration renewal in 2008. These made it necessary to create new or updated application exhibits. The intensity of the recent winter storms caused transportation and staff coordination problems that hampered the compilation, verification and preparation of the exhibits and delayed the filing.

Throughout this process we have been in continuous communication with Robert Wyatt of Commission staff to alert him of our situation.
