

On April 28, 2010, Concord Steam Corporation (Concord Steam) filed a petition for approval of its proposed amendments to a special contract with the Concord Family YMCA. On September 9, 2010, Staff filed a recommendation in the docket summarizing the investigation into the contract and its amendments and recommending numerous changes to the document.

Since that time Staff has been working with Concord Steam on a settlement on the revised contract language. Staff anticipates that the settlement will be filed soon and requests that the Commission take no action on the petition until the settlement is filed, or November 15, 2010, whichever occurs first.
