

Dear Ms. Howland:

On April 30, 2010, Public Service Company of New Hampshire (PSNH) filed a proposed reconciliation of its 2009 energy service and stranded cost recovery charges in the above-captioned docket. Pursuant to an Order of Notice issued by the Commission on June 1, 2010, the Commission held a prehearing conference on June 28, 2010. In addition to hearing the preliminary positions of the parties at the prehearing conference, the Commission considered pending motions to intervene and took suggestions on the scope of the docket. Given the range of opinion on the scope of the proceeding, the Commission took the issue under advisement and said it will issue a procedural order clearly stating the scope of the proceeding.

The Commission granted the motions to intervene filed by the following parties: TransCanada Power Marketing Ltd and TransCanada Hydro Northeast Inc. (TransCanada), Conservation Law Foundation and New Hampshire Sierra Club.


