Errata: Re: Motions for Protective Orders

Dear Secretary Howland:

It has come to my attention that several Motions for Protective Orders I filed in this docket include the same typographical errors. The motions are (i) the Motion for Protective Order re: Financial Forecast, requested by Staff Set 1, Q-Staff-003, dated July 16, 2010; (ii) the Motion for Protective Order re: Revolving Credit Agreement Summary Terms, requested by OCA Set 1, Q-OCA-007; dated July 16, 2010; (iii) the Motion for Protective Order re: Assumptions Underlying Financial Forecast, requested in Technical Session, Q-TECH-002, dated August 3, 2010; and (iv) the Motion for Protective Order re: Draft Northeast Utilities Operating Company Credit Agreement, requested by OCA Set 1, Q-OCA-007, dated September 10, 2010 (the "Motions"). (The two Motions relating to OCA Set 1, Q-OCA-007 relate to an initial and a subsequent, follow-up response to the same request.)

The first line of page 1 of the Motions correctly references N.H. Admin Rules Puc §203.08, *Motions for Confidential Treatment*, but on subsequent pages several Motions incorrectly reference the prior Commission rule regarding confidential treatment, N.H. Admin Rules Puc §204.06. The references to N.H. Admin Rules Puc §204.06 should be corrected to refer to the current rule, N.H. Admin Rules Puc §203.08 (except when included in quotations from Commission Orders issued under the prior rules or references to decisions under the prior rules).


The Motions also include a very awkward and incorrect sentence, "The limited benefits of disclosing the information outweigh the harm done by disclosing the information." In all Motions this phrase or sentence should be corrected to read, "The

limited benefits of disclosing the information are outweighed by the harm that would be done by disclosing the information.”

I apologize for any confusion and inconvenience these errors may have caused the Commission, Staff and other Parties.


