



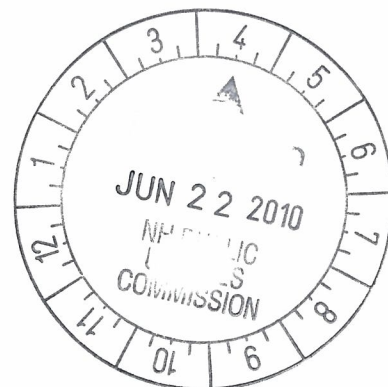

**RE: Unlimited Dialtone and Unlimited CustopAK (FairPAK) Business Bundles**

Dear Ms. Howland:

This is to advise you that Northern New England Telephone Operations LLC d/b/a/ FairPoint Communications – NNE plans to offer a permanent tariff change effective July 22, 2010. Tariff changes consist of:

This filing introduces a change in Regional Bundles which will be available for business customers with 1 to 25 access lines. This filing will provide limited rate reductions and add additional term options to the current bundles. These offerings bundle local voice, certain value added services, intrastate toll and a choice of FairPoint Communications Long Distance calling options. Optional discounted services will also be available and shall include: voicemail, toll free service, high speed internet and internet-based services. The bundle will offer one, two and three year term plans.

The bundle option includes an access line with unlimited local calling, a combination of any of the following features (caller ID w/name, three way calling or call forwarding), unlimited intrastate toll and the choice of interstate long distance with FairPoint Long Distance.

As a note, on June 17, 2010 FairPoint Communications filed Illustrative Replacement tariffs for all of our tariffs in order to remove all references to Verizon and Verizon products. This filing is being made to the existing tariff utilizing the Verizon name and will be incorporated into the illustrative tariffs when they are made permanent.

As part of and in support of its filing, FairPoint Communications, Inc. submits records and information that are subject to confidential treatment pursuant to RSA 378:43. These records, which have been marked "confidential", pertain to the provision of competitive services; set forth trade secrets or other confidential information falling within the scope of RSA 378:43, II(b); and are not general public knowledge or published elsewhere, the Company having taken measures to prevent dissemination of the records and information in the ordinary course of business.
