On August 29, 2011, you filed on behalf of EnergyNorth Natural Gas, Inc. d/b/a National Grid NH and Granite State Electric Company d/b/a National Grid (collectively, "the Companies") a request to extend the time to September 7, 2011 to file reports and other filings in a number of matters in which a deadline applicable to the Companies to make such filings occurs during the week of August 29, 2011.
