To the Parties:

On July 13, 2012, a supplemental order of notice relative to electric utilities was issued in the above referenced proceeding. The supplemental order of notice established July 27, 2012 as the date by which any party seeking to intervene should file its petition to intervene.

On July 19, 2012, the Community Loan Fund filed a petition to intervene. On July 23, 2012, the Retail Merchants Association of New Hampshire (RMANH) and New Hampshire Housing Finance Authority (NHHFA) filed petitions to intervene. TRC and The Jordan Institute filed petitions to intervene on July 27, 2012.

The Commission has determined that no party will be prejudiced by granting the petitions to intervene, which are consistent with the applicable standards for intervention. Accordingly, the Community Load Fund, RMANH, NHHFA, TRC and The Jordan Institute are granted intervenor status.
