On September 10, 2010, Concord Steam Corporation (Concord Steam), a public utility supplying steam service to approximately 110 commercial and institutional customers and one residential customer in Concord, filled its annual cost of energy (COE) rate for the period November 1, 2010 through October 31, 2011. The proposed COE rate is \$16.64 per Mlb, which is a decrease of \$1.19 per Mlb when compared to the projected weighted average COE rate of \$17.83 per Mlb for the year ending October 31, 2010, resulting in a decrease of approximately 4% in an average customer's total bill. The petition and subsequent docket filings, other than information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at http://www.puc.nh.gov/Regulatory/Docket/2010/10-242.htm.
The filing raises, inter alia, issues related to the forecast of sales, supplier and transportation prices, estimated wood vard operations expenses, purchasing decisions related to current and past annual fuel supplies, the causes and treatment of over and under recoveries, prior period costs and revenues, and the justness and reasonableness of the proposed COE rate. Each party has the right to have an attorney represent them at their own expense.
