SECOND NOTICE OF NON-COMPLIANCE AND NON-PAYMENT**

Dear Sir or Madam:

This letter represents a second notice of non-compliance and non-payment, following up on the first notice letter sent to you on August 17, 2016.


Pursuant to Puc 2503.03(a) and RSA 362-F:8, competitive electric power suppliers were required to file an Annual Renewable Portfolio Standard (RPS) Compliance Filing with respect to the 2015 compliance year on or before July 1, 2016. Under Puc 2503.03(c) and RSA 362-F:10, II, the full amount of any alternative compliance payments (ACP) due with respect to compliance year 2015 was required to be paid to the New Hampshire Public Utilities Commission at the same time as the filing of the Annual RPS Compliance Report, on or before July 1, 2016, with either a check made payable to the State of New Hampshire or through electronic transfer to the renewable energy fund bank account. To date, however, neither the required Annual RPS Compliance Report nor the required ACP has been received from Glacial Energy of New England, Inc. (Glacial Energy).

Please file the required Annual RPS Compliance Report and pay the full ACP amount for the 2015 RPS compliance year within thirty (30) days of the date of this letter. Commission Staff has estimated that the ACP amount due for the 2015 RPS compliance year is \$225,653. In addition, please pay the full outstanding ACP balance of \$24,470 due for the 2014 RPS compliance year within thirty (30) days of the date of this letter.

If full payment is not received by such date, then the Glacial Energy ACP account balance may be subject to further collection action, including referral for collection to the New Hampshire Department of Justice pursuant to RSA 7:15-a.
