Dear Ms. Inman:

By Order No. 25,287 (November 9, 2011) entered in the above-captioned docket, the New Hampshire Electric Cooperative, Inc. (NHEC) was directed to file by January 31, 2012 a plan to address any over- or under-recovery in the stranded cost recovery balance as of December 31, 2011.

On January 25, 2012, NHEC filed a letter stating that, as of December 31, 2011, the stranded cost recovery balance was an under-recovery of \$33,360. NHEC proposes to forego recovery of the remaining balance and absorb the under-recovery into its cost of operation. NHEC states that it would not be cost effective to collect this amount and that the unrecovered revenue will have minimal impact on its financial statement.

The Commission has reviewed the request and determined that NHEC has complied with the requirements of Order No. 25,287. Accordingly, NHEC's proposed disposition of the stranded cost recovery balance has been approved.
