

A SURCHARGE to recover the difference between the amount billed by the Company for water for the two quarters ending March 31, 2012 and the amount which would have been billed by the Company for said quarters if the Company had employed the customer charge and rate based upon metered service set forth in the rate schedules in the Company's Tariff NHPUC No. 2 - Water. Bills for this surcharge are net, and will be rendered in June 2012. The surcharge shall be paid in two installments.

A. First Installment: For the quarter ending December 31, 2011. Payment is due Twenty-five (25) days after the mailing of the bill. The amount of the first installment is set forth in paragraphs 1 through 4 of this section A.

A Customer Charge of \$1,308 less the Customer Charge billed by the Company for the quarter ending December 31, 2011, plus

A charge based upon metered service of \$15.0495 per hundred cubic feet of water used in said quarter less the charge based upon metered service billed by the Company for the quarter ending December 31, 2011.

A charge based upon metered service of \$5.3388 per hundred cubic feet of water used in said quarter less the charge based upon metered service billed by the Company for the quarter ending December 31, 2011.

A charge based upon metered service of \$5.3388 per hundred cubic feet of water used in said quarter less the charge based upon metered service billed by the Company for the quarter ending December 31, 2011.

A charge based upon metered service of \$5.3388 per hundred cubic feet of water used in said quarter less the charge based upon metered service billed by the Company for the quarter ending March 31, 2012.
