ARTICLES OF INCORPORATION

OF

NEW HAMPSHIRE FIBER NETWORK, INC.

THE UNDERSIGNED, ACTING AS INCORPORATOR(S) OF A CORPORATION UNDER THE NEW HAMPSHIRE BUSINESS CORPORATION ACT, ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION:

FIRST: The name of the corporation is New Hampshire Fiber Network, Inc.

SECOND: The total number of shares of stock which the Corporation shall have authority to issue is 1,000 shares of common stock, with no par value (the "Common Stock").

THIRD: The address of the initial registered office of the corporation is 310 Nesmith Hall, Durham, New Hampshire 03824, and the name of its initial registered agent at such address is Ronald Rogers, Esq.

FOURTH: The name and address of each incorporator is:

FIFTH: The capital stock will be sold or offered for sale within the meaning of New Hampshire RSA Chapter 421-B. (Uniform Securities Act)

SIXTH: To the fullest extent now or hereafter permitted by law, no director or officer of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for any action or failure to take action as a director or officer. No amendment or repeal of this article shall have any effect on any right or protection of any director or officer for or with respect to acts or omissions occurring prior to such amendment or repeal.

EIGHTH: The purpose of the corporation is to own, build, install and maintain open-access, high-speed middle mile fiber optic networks within the State of New Hampshire (and outside New Hampshire to the extent necessary or advisable in order to support such networks), on poles and underground, for the purposes of leasing, selling or otherwise making available fiber optic pathways to broadband service providers and other entities with the goal of improving access to high-speed broadband service in New Hampshire, including, but not limited to, access to broadband service in those regions of New Hampshire that historically have not had such access. The corporation may use grants from governmental and other programs specifically targeted toward broadband and telecommunications infrastructure improvement, as well as private investment. In addition, the corporation may engage in any other lawful activity for which a corporation may be organized under the New Hampshire Business Corporations Act.




