

On January 13, 2011 Innovative Energy Advisors LLC (Innovative) notified the Commission of its intent to provide electric aggregation service. Pursuant to Puc 2006.02(a)(5), Innovative did not provide a copy of the applicant's authorization to do business in New Hampshire from the secretary of state with its original application. On February 16, 2011 Innovative provided its application to the secretary of state (attached). The document shows that it was filed on December 23, 2010 and a Business Id was assigned. Staff verified the information that Innovative is authorized to do business in New Hampshire.

The application by Innovative to provide electric aggregation service has been reviewed and the Company has complied with the requirements of Puc 2006.02. Staff recommends that Innovative Energy Advisors LLC be registered to provide electric aggregation service in New Hampshire.
