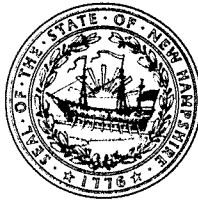

Registration as a Natural Gas Aggregator

Dear Mr. Pandit:

On February 22, 2011, Early Bird Power LLC filed with the Commission an application for registration as a natural gas aggregator. On March 28, 2011, after an earlier conversation with Commission staff, Early Bird Power LLC filed an addendum addressing the requirements of N.H. Code Admin. Rules Puc 3006.02(a)(5) and Puc 3006.02(a)(8) to satisfy the remaining registration application requirements not addressed in the initial filing.


The Commission has reviewed the application for registration as a natural gas aggregator and has determined that it meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.04. Therefore, the Commission will approve Early Bird Power LLC as a natural gas aggregator in the State of New Hampshire, with the registration to be effective today, April 1, 2011. This initial registration will expire at the end of business on March 31, 2013.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator applicant shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Early Bird Power LLC, on or before February 1, 2013.
