- I am not required by law or mandate to choose an alternative supplier and the sales representative represents People's Power & Gas, LLC, ("People's Power"). The Customer has the right to rescind this agreement, without fees or penalties of any kind, within three (3) days after executing this agreement. All information provided is confidential and not released without written authorization or obligated by law.
- I agree that email, phone and/or SMS texting are acceptable forms of communications for any regulatory or state compliance filings or People's Power & Gas notifications.
- The business or residence named above ("Customer") will pay a variable rate determined by People's Power for electricity may fluctuate on a monthly basis according to our LMP cost. Fixed rate is per kWh regardless of usage amount. The People's Power rates do not include but not limited to transmission and delivery charges, systems benefit charge, standard cost recovery, any taxes and any tariff charges. The initial Term shall commence on the transferred meter read date, and continue until December 31 of the following calendar year. Thereafter, the Term shall be for a twelve month period, from January 1 through December 31 of each calendar year. Customer may cancel this Agreement with a 60 day notice prior to the end of the Term.
- Customer acknowledges that the Local Distribution Company ("Utility") will continue to deliver electricity and/or natural gas purchased from People's Power, read my meter and respond to emergency service as required by any Federal and State Public Utility Commission.
