On August 7, 2012, the Commission received a request from PNE Energy Supply LLC (PNE) to extend its territory as a Competitive Electric Power Supplier (CEPS) to the franchise territory of Unitil Energy Systems, Inc. (UES). PNE also provided the Electronic Data Interchange (EDI) certification letter from UES. PNE updated its application with documentation demonstrating successful completion of the testing.
