Dear Ms. Hamilton:

On May 6, 2011, the New Hampshire Public Utilities Commission (Commission) received an application from Conservation Services Group on behalf of Princeton Crossing L. P. requesting certification for the Princeton Commons photovoltaic facility as a Class II renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. On May 19th Staff sent Conservation Services Group a letter requesting additional information; your answers were received June 15. Upon further review Staff has noted several additional questions that must be addressed before your application is considered complete:

- 1.) Why do the facilities have individual meters when they have one GIS identification number?
- 2.) Is the Boston Road facility reported to GIS as a single production or do they report Buildings 2, 3, 4, & 5 facility by facility?
- 3.) Does Building 1 have its own GIS number?
- 4.) Why isn't Building 1 included in the application? Is it being certified under the Massachusetts program?

5.) Docket No. DE 10-156 was for Princeton Properties Solar Aggregation (Princeton Aggregation). The current docket (DE 11-100) is for Princeton Crossing. Your request is for the Princeton at Boston Road solar unit. Staff recognizes that the "Princeton" name is being used by the Operations Manager, Kurt Shillington in all instances, but we would like some clarification about the name variations and legal standing to use these name variations.

These items must be received by the Commission to complete your application. Until such time, it will not be processed. If the requested information and documentation are not provided within ten business days, your file will be closed without prejudice. Please refer to docket number DE 11-100 in all future correspondence with the Commission. Should you have any questions, please do not hesitate to contact me.
