Re: DE 11-100, Conservation Services Group's Application for Class II Eligibility of the Princeton Commons, Boston Road Photovoltaic Facility Pursuant to RSA 362-F on Behalf of Princeton Crossings, L.P.

Dear Ms. Hamilton:

On May 19, 2011, Conservation Services Group (CSG) submitted an application on behalf of Princeton Crossings, L.P. requesting certification of the Princeton Commons, Boston Road (Boston Road) photovoltaic facility<sup>1</sup> as eligible to produce Class II renewable energy certificates (RECs), pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard (RPS) law. Staff reviewed the application and requested additional information on May 19, 2011 and CSG responded with information on June 15, 2011. A second request for information was sent July 25, 2011; information required to complete the application was received August 2, 2011. Staff has reviewed CSG's submitted information and recommends approval of your request, noting the application was completed as of August 2, 2011 in accordance with New Hampshire Code of Administrative Rules Puc 2500.

Class II eligibility requires a facility to produce electricity from solar technologies and to have initiated operation after January 1, 2006. The application indicates the Boston Road facility is a customer-sited photovoltaic facility that includes four (4) units; the total name plate capacity of the system is 120.96 kilowatts (kW). The system began operation on November 4, 2010. The facility's New England Power Pool (NEPOOL) Generation Information System facility code is NON 32919.

<sup>1</sup>The Princeton Commons Boston Road Facility is located at 499 Boston Road in Billerica, Massachusetts and includes Buildings 2, 3, 4, &5. The Boston Road facility is located in Billerica; Lowell is the mailing address.

Because the facility is a customer-sited source, its output is not recorded in the NEPOOL Market Settlement System and, as a result, its output must be monitored and verified by an independent monitor. The application states that PowerDash LLC will monitor the facility's output as required by the New Hampshire Code of Administrative Rules Puc 2505.09.<sup>2</sup>


Each array's New Hampshire certification code is listed in the following table.

Based on Staff's determination that CSG has provided all the necessary information to demonstrate that the facility is eligible for certification to produce New Hampshire Class II RECs the Commission hereby certifies the Boston Road facility as eligible to receive New Hampshire Class II RECs. To ensure CSG does not receive Class II RECs for output from facilities not approved for Class II eligibility, CSG must report to the Commission the total output associated with the facilities after August 2, 2011. Specifically, CSG must provide each facility's kilowatt-hours (kWh) produced during the relevant quarter, total kWh produced prior to the Commission approval date to produce Class II RECs, and total kWh produced after the Commission approval for Class II RECs. CSG must submit this quarterly data to the Commission before the NEPOOL GIS deadline for reporting customer-sited facility output.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire RPS certification code for the Princeton Aggregation for use in the NEPOOL-GIS is NH-II-10-091.

Dear Mr. Webb:

The New Hampshire Public Utilities Commission has certified the Conservation Services Group's (CSG) Princeton Crossings L.P.'s (Princeton Commons) Boston Road facility located at 499 Boston Road, Billerica, Massachusetts as part of the Princeton Aggregation eligible for Class II Renewable Energy Certificates (RECs) (RSA 362-F). Accordingly, the Boston Road facility (consisting of Buildings 2, 3, 4, and 5) is eligible to be issued New Hampshire Class II Renewable Energy Certificates (RECs), effective August 2, 2011, the date on which the Commission awarded New Hampshire Class II REC eligibility for the four facilities listed in Table 1.

To ensure that CSG is only credited for Class II RECs from the output of facilities approved for Class II eligibility, PowerDash, LLC must verify and report to both the Commission and the NEPOOL GIS the total output associated with these facilities after the Commission issued effective date of August 2, 2011. The New Hampshire certification codes for the four Princeton Commons Boston Road photovoltaic facilities are provided in Table 1. The New Hampshire certification code for the Princeton Properties Solar Aggregation is NH-II-10-091.
