

- Although Freedom has common ownership with NH approved electricity supplier Halifax American Energy Company/South Jersey Energy Company (“HAEC/SJEC”), Freedom does not write any electricity supply contracts on their behalf. Also, Freedom does not possess, reference nor utilize any exclusive marketing relationship with HAEC/SJEC. Freedom also has common ownership with PNE, a potential New Hampshire electricity supplier, with an application for approval currently before the Commissioners.

**Statement of Activities Since February 18<sup>th</sup> Expirations:**


- Freedom has not been involved with any commercial electricity aggregation since our registration expired on February 18<sup>th</sup>, 2011.

**Statement of Resident Power Activities:**

- Freedom has been active in the New Hampshire residential market through its Resident Power division, however no residential customers have been quoted from a supplier as of yet. Resident Power to this point, has been offered as a division of Freedom Logistics and not as a separate entity. A new company has been formed called Resident Power Natural Gas and Electric Solutions, LLC (“RPNGES”). RPNGES currently has a notice of registration pending with the PUC and intends to take over the Resident Power division once approved, as well as use the Resident Power trade name.

A copy of Freedom’s authorization to do business in the state of New Hampshire is already on file with the NH PUC. If an additional copy is needed, please let us know.
