Re; Rosebrook CIAC Funds

Dear Ms. Howland:

In the Settlement Agreement ("Agreement") between the Rosebrook Water Company ("Company") and the Public Utilities Commission Staff ("Staff") in DW 06-149, the Company agreed to seek prior approval of the Public Utilities Commission regarding use of funds from the CIAC account. The Company has recently met with Staff. The Company has also filed a letter dated March 31, 2011 addressed to Mr. Naylor regarding a comprehensive response to the Agreement including provisions pertaining to CIAC.

The Company respectfully requests use of its entire CIAC fund amounting to \$212,350 as of March 31, 2011. The CIAC funds will be used to fund the Company 2011 Capital Improvement Plan ("CIP") amounting to \$200,550 - \$219,450. See enclosed CIP. Also, enclosed is a brief description of each project and the estimated costs.

The Company has already begun some of the work (although it has not expensed any CIAC funds). It would like to commence the projects this spring and summer and complete them this fall.

The Company believes the improvements will cure certain "lesser deficiencies," lessen the water pressure, allow the Company to better operate and maintain the system and increase the system reliability.


