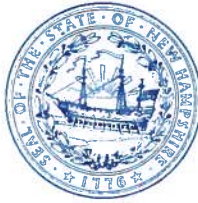

Renewal Registration as a Natural Gas Aggregator

Dear Mr. Griffin:

On June 6, 2011, Fidelity Energy Group, LLC (Fidelity Energy Group) filed with the Commission an application for renewal registration as a natural gas aggregator, together with the renewal application fee of \$125.00.

The Commission has reviewed the renewal application for registration as a natural gas aggregator and has determined that it meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.05. The Commission will approve the registration with an effective date of September 17, 2011, which coincides with the expiration of the existing registration for Fidelity Energy Group. The renewal registration will expire at the end of business on September 16, 2016.


Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Fidelity Energy Group, on or before July 18, 2016.
