Revised Procedural Schedule

To the Parties:

By letter dated August 7, 2014, Commission Staff recommended that the Commission appoint a hearings examiner to conduct a meeting of the parties to review discovery issues, to propose a revised procedural schedule that accommodates motion practice related to the rebuttal testimony, and to consider changes to the schedule for prehearing motions and for a hearing on those motions.

After consideration of Staff's recommendation, and with a goal of holding the merits hearing as scheduled, the Commission has appointed F. Anne Ross, Esq., to conduct a technical session on August 18, 2014, at 10:00 a.m. Ms. Ross is to preside over an informal discussion concerning any remaining discovery disputes and to take comments on the following proposed procedural schedule:

- 9/8 PSNH Objections to Motions to Compel
- 9/9 Hearing on Motions to Compel
- 9/12 Prehearing Motions Deadline (extended from August 22)
- 9/22 Hearing on Prehearing Motions at 1:30 p.m. (extended from Sept. 17)
