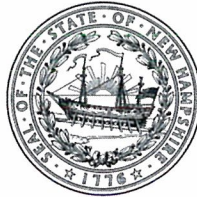

Dear Ms. Howland:

We have each been actively involved in negotiating a comprehensive settlement with Public Service Company of New Hampshire d/b/a Eversource (PSNH). We have reached an agreement with the other settling parties and have agreed to finalize and execute a settlement agreement embodying all terms of a settlement as soon as possible. The parties to the settlement intend to file the settlement with the Commission in the above captioned dockets and to seek Commission approval, while simultaneously attempting to have legislation enacted to facilitate the terms of the settlement.

As a result of these activities, as well as our commitment to support the settlement before the Commission, we ask that the Commission designate us as Staff Advocates in the above dockets pursuant to RSA 363:32, II. We believe that these dockets represent matters that are both controversial and significant in consequence. Further, the settlement itself meets both those tests by reaching agreement on PSNH's divestiture of generation assets, as well as recovery of the costs of its investment in the Merrimack Scrubber.
