**Investigation of Merrimack Station Scrubber Project and Cost Recovery**

**Procedural Order Re: Closing Docket**

On February 4, 2022, the Commission issued Order No. 26,577, an order *nisi*, in Docket Nos. DE 11-250 and DE 14-238. Order No. 26,577 set a deadline of February 15, 2022 for filing comments and requests for a hearing. The Office of the Consumer Advocate (OCA) filed a timely request for a hearing, which was supported by the New Hampshire Department of Energy (DOE) and Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource).

A joint motion for rehearing of Order No. 26,577 was filed on March 21, 2022 by the OCA, Clean Energy New Hampshire, Conservation Law Foundation, the DOE, and Eversource in Docket No. DE 22-004, a new docket opened pursuant to Order No. 26,677 to accept subsequent filings related to implementation of the Clean Energy Fund. Following a hearing, the Commission resolved this matter by issuing Order No. 26,636 on June 7, 2022.

A review of Docket No. DE 11-250 indicates that no further action by the Commission is necessary. Therefore, this docket is now closed. Filings regarding implementation of the Clean Energy Fund should be made in Docket No. DE 22-004.
